- 2. All Workshop accounts are payable by 30th of the month following date of the invoice.
- 3. Non-payment by due date may result in your account being temporarily suspended.
- 4. Petrocell Holdings Ltd reserve the right at any time, at our absolute discretion, to demand immediate payment of any account whether due or not.
- 5. Payments should be made on the basis of invoices received from our branches. Please do not wait for our statement.

6. Motor Fuel Accounts

A security deposit equivalent to 4 weeks purchases is required for all motor fuel accounts. We may require this deposit to be increased in line with current sales. The security deposit must NOT be regarded as an advance payment and monthly motor fuel accounts must be paid in full by the 15th and 30th of the following month, even if monthly purchases are less than the security deposit.
